

# MALAYSIA MY SECOND HOME (MM2H)



## BASIC REQUIREMENTS

<b>Age of Main Applicant</b>	➤ 25 years old
<b>Allow to bring</b>	➤ Spouse ➤ Unmarried children < 34 years old ➤ Parents/Parents-in-law ➤ Maid (only for Platinum)
<b>Residency Requirements –</b> (only apply if main applicant is below 50 years)	➤ Minimum 90 days per year cumulatively for whole family. [Not applicable for Main Applicant above 50 years old]
<b>Police Clearance Certificate</b>	➤ Main Applicant, Spouse & Dependents > 18 years old
<b>Marriage Certificate</b>	➤ If spouse is included in the application
<b>Children's Birth Certificate</b>	➤ If children are included in the application

## APPLICATION PROCESS

1. Sign Agreement & pay 20% deposit (application fees)
2. Prepare Documentation
3. Submit Application
4. Receive Approval Letter (AP) & pay remaining 80% fees of application fees
5. AP only valid for 90 days
6. Enter Malaysia within 90 days
7. Visa endorsement on Passport
8. Congratulation you are officially MM2H Visa Holder

## DOCUMENTATIONS

1. Passport (Personal Data Page) – min 1 year validity
  2. Resume of Main Applicant & all above 18 years old
  3. Employment Letter & Business License
  4. Latest 3 months bank statements
  5. Police Clearance Certificate
  6. Marriage Certificate (★)
  7. Children Birth Certificate (★)
  8. 4 Passport size photos (3.5\*5cm) – Blue background
- ★ To be translated into English and certified by Malaysia Embassy /Malaysia Consulate.

## AFTER APPROVAL

1. Open bank account in Malaysia for Fixed Deposit (FD)
 

	Silver	Gold	Platinum
FD	USD150,000	USD500,000	USD1 million
Property	RM600,000	RM1 million	RM2 million
2. Purchase Medical Insurance (below 60 years old)
3. Brief medical assessment
4. Property Ownership within 1 year of obtaining MM2H Visa

## APPLICATION FEES (per family)

1. Silver - RM40,000
2. Gold - RM55,000
3. Platinum - RM70,000
4. Participation Fees (one off) payable to Immigration
  - Silver RM1,000 (one off)
  - Gold RM3,000 (one off)
  - Platinum RM200,000 (one off)
5. MM2H Visa Fees - RM530/ year per dependent
6. Government Processing Fee - RM2500 per dependent (one off)

\* The above fees are subject to government regulations.\*
